Renee explained the new budget document, linked. We have the final total of reimbursement available from the city (\$1000). There are questions surrounding what is reimbursable, like the SS gates and the GT Girls.

We are considering buying 4th of July insurance, and the payment value for the guest speakers for general meetings. Christina's balance report was right on with the spreadsheet.

Maddie raised the question: how low is too low for our bank account to be at? Do we want to set an amount that we're comfortable with?

- Zoe asked how long the city reimbursement process is, and Deb and Christina said that we should be able to submit for that as we go.
- Decided that we will try to submit the SS Gate cost and the Guest Speakers to the City. Projected to have \$1051 in the bank after reimbursements are submitted and approved.

Renee will be submitting the change in officers to the city. The signature Authorization form will need to be completed at the beginning of each year.

We chatted about bringing up the budget at the next general meeting, so that we could engage members in donating money towards the cause of throwing events.

c. MNAC Representative Report

i. Roster update status

City publishes a roster of the NA's and they have updated it within the city, but they only show our MNAC reps and not our president's contact. Instead it links to our website. Deb had only ever submitted an application to be the secondary MNAC rep, but never submitted an app for the main rep. Technically the mayor has to accept your application, so Deb is going to submit that application, but is still able to attend meetings in the meantime.

We'll tell Greg that he will need to submit an "alternate rep" agenda as well.

City received a grant for Solar Arrays that could maybe power 100 homes.

B-Ham is selected as a "Fan Zone" for the upcoming World Cup, so we as a city are preparing for many visitors.

Lobbying hard at the state level to keep city funding.

1.8mil in projected spending for new city ordinances, we're now at our "Emergency Reserve Floor". 32 full time positions with the fire department are at risk for firing if the federal funding falls through.

Someone next door is making a fuss about the Post Point Water Treatment Plant not being compliant in terms of emissions. It's now under investigation.

Birchwood is going to be hosting a new "tiny home village".

Birchwood is going to lobby for quieter trains within Bellingham just like as accomplished in Fairhaven.
